EAGLES THEATRE



After two years of renovation, Eagles Theatre celebrated its grand reopening in February 2020.

Originally constructed in 1906, Eagles Theatre once entertained crowds with energetic vaudeville performances. It now offers visitors from across the region opportunities to see live performances, enjoy movie showings, and attend special events in a truly remarkable setting.

The five-story renovated arts and entertainment facility features two theaters: the original Eagles Theatre and the new Ferguson Theatre. The 560-seat Eagles Theatre combines nostalgia with modern upgrades and amenities. The historical integrity of the 114-year-old theater has been maintained while adding comfortable seating, private upper balcony suites, and state-of-the-art projection, sound and lighting. The Ferguson Theatre, located on the lower level, is a 49-seat movie theater that offers first-run movies as well as sensory-friendly showings, independent films, student showcases, and more.

The top floor of Eagles features the breathtaking Parkview Ballroom, one of the more extensive features of the renovation. As one of the original rooms of the 1906 construction, the elegant event space has been restored to its former glory with a hand-painted ceiling and other intricate details and features. Full catering is available, making the Ballroom a perfect place for weddings, receptions, corporate meetings, and other special events and celebrations.

Additional floors of Eagles house several conference rooms available for rent, music lesson rooms, and media arts classrooms where students can learn audio and video production and editing.

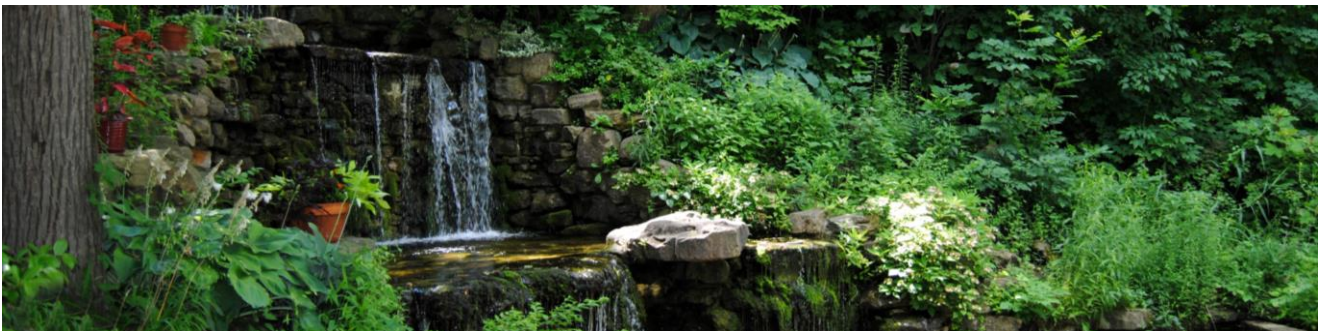
